Cold Lake First Nation assists families of deceased members of Cold Lake First Nation.

This program will assist the family of deceased CLFN member for costs associated with funeral feast expenses in the amount not to exceed \$2500.00.

In addition, this program will assist the family of deceased member of the Cold Lake First Nation for costs associated with funeral home expenses. These expenses may be made directly to the funeral home or by reimbursement if the applicant has paid the funeral home directly. These payments will not exceed \$2000.00. The funeral feast amount is eligible to be used for funeral home costs.

Conditions of eligibility to apply

- Deceased must be a registered Cold Lake First Nation (CLFN) member
- Must provide death certificate/invoice from funeral home upon receipt;

Fiscal year

- April 1 – March 31 – program funding year – receipts older than funding year not eligible (with the discretion of manager under special circumstances).

The funeral home, in most cases invoices the Nation directly, for costs up to \$2000.00. However, if applicant has paid vendor directly, the applicant can apply to a maximum of \$2000 with receipts and death certificate.
