ACCESS APPROVAL -
COLD LAKE AIR WEAPONS RANGE (CLAWR)

1. 4 Wing approves CLFN access to the CLAWR within the green zones indicated on Figure 1 below from 1800 hours on 19 November until 0700 hours on 22 November 2021. In addition, 4 Wing will grant 24 hr access to the purple zone from 1800 hrs 19 November to 0700 hrs 26 November 2021. The CLFN members will be allowed to travel within 100 meters of the Lake shore to expedite access to the Purple area. Please note that hunting is not permitted within the purple zone for safety reasons, and access to Primrose Lake will be allowed from 1800 hours 19 November until 0700 hours 22 November 2021. Due to the unfortunate loss of an aircraft and a member of 4 Wing, a 3 square mile box (see para f.) around the crash site is off limits to all personnel. The access area boundaries are outlined by the coordinates below:

The Sand River is the western boundary of the # 2 access area and
access to the CNRL area is denied due to concentrations of H2S;
